- 1. Review and Approval of August 2020 minutes.
  - a. Revise to state that both CGSAL and the coordinators approve transfer credits.
  - b. Motion to approve with update: S. Warner motion. J. Baker second. Approved.
- 2. Updates and Announcements:
  - a. Enrollment projection in university strategic plan related to graduate students
    - i. Graduate Studies is already a growth leader. Kudos to the group.
    - ii. Past success is future promise.
    - iii. We are expected to increase enrollments 20% (to 1200) over 5 years.
    - iv. Think about the best ways to ensure enrollment and continuation with program and certificate students rolling into master's programs.
    - v. Increase in international students is also a goal.
    - vi. This is a concerted effort over all the grad programs.
    - vii. There is a capacity for increased resources but we must show growth first.
    - viii. More marketing money will be available.
    - ix. It was pointed out that programs could be stronger with faculty teaching only grad courses.
    - x. A reminder that one tenure track faculty = 1 FTE, even with a credit overload.
    - xi. A reminder to submit DL proposals to CAP for spring. An expedited process is being formed but not a blanket process. Fall was an exception.
  - b. Washington Monthly magazine annual rankings
    - i. MU was the highest-ranked PASSHE institution and the only one in the top 100 in the master's university ranking.
  - c. Middle States Results
    - i. They did not say anything specific about Graduate Studies.
    - ii. Overall some suggestions for MU but no report is due.

      - 3. Action Items:

- a. SOWK DSW Curriculum Change

  - ii. This takes 3 electives off and adds one comprehensive seminar.

- b. Transfer Credit Guidelines
  - i. The PASSHE policy says 1/3 of credits can be transferred (2/3 residency required) which does not match the 40% or 50% proposed by the subcommittee so the topic needs to be revisited.
  - ii. The minimum grade for accepting a transfer course was questioned. The graduate catalog states a B- or higher.
  - iii. Also questioned was transferring credits used in another master's degree. This is not allowed, as stated in the graduate catalog. There are exceptions in some programs.
