Course OverviewParticipants will investigate mathematics teaching and learning from both teacher and stundt perspectives. Course participants will engage in mathematical problem solving and in the study of mathematics as the foundation for understanding current curriculum and standards. Lesson planning follows from the consideration of different types of mathematical content, including skills and concepts. Looking specifically at the learning of mathematics and questioning to promote higher-thinking, this course prepares students for field experiences in secondary mathematics classrooms
