### Obtaining Information, Support and Assistance, Filing a Complaint

If you have been impacted by sexual misconduct, there are a number of ways to report the incident and a wide array of services available to obtain the information, support and assistance you need to ensure your health and safety. ### IMMEDIATEL AFTER AN INCIDENT

#### REPORTING THE INCIDENT

You are strongl encouraged to report se ual violence to the police.

Report sexual misconduct to the police by calling one of the numbers below. You may also report, in person to any police o cer. If you seek medical care at Lancaster General Hospital, you can ask to report the sexual misconduct incident at that time as well. Your decision to report to the police will not a ect your ability to le a complaint through the University's conduct process (see back), which is independent of the criminal process.

#### **SEEKING PROTECTIVE SERVICES**

#### **Universit Protective Services**

Once noti ed of the assault, if both parties involved are students, the University is able to impose a "no-contact order," a document that orders parties to refrain from having in-person or electronic contact with each other. Violation of the no-contact order is enforceable through the University's Code of Conduct, and the order may be issued whether or not there is a formal complaint led. In addition, the Title IX o ce may assist with room changes or emergency relocation options when the parties live in close proximity or have classes or other activities in common.

# REPORTING OPTIONS

You have several options for ling a report of sexual assault. You may pursue all or none of these options. You are not required to le a report immediately; however it is important to preserve any evidence of the sexual assault.

#### **Police Report (Criminal Investigation)**

Students are encouraged to report sexual assault to the police. Both the police department and District Attorney's o ces are victim-centric. Police do not force individuals to "press charges." It is the rst step of a criminal investigation. The goal of a criminal investigation is to determine if a crime has occurred and if a suspect can be linked to the crime. The Millersville police department will involve a YWCA advocate during the initial stages of a police report. All other Lancaster departments will involve a YWCA advocate upon a hospital medical exam if not earlier. Police will not charge a complainant who had been drinking with underage drinking charges.

#### **Anon mous Complaints**

You may le an anonymous complaint through Student Conduct online: www.millersville.edu/studentconduct. However, Iling out a complaint anonymously limits Student Conduct sta in o ering support services and their ability to investigate and respond to the incident.
